



Protection of Personal Information Act (POPIA)

Privacy policy:

It's our promise to customers that we respect the trust you place in us and the privacy of the information you share. Part of providing superior customer service includes making sure that we're building a relationship of trust with our customers. Our way of doing that is to let you know in a clear, prominent, and easily accessible way how we collect, use, and above all protect your personal information.

In this policy, "we", "us" or "the Company" refers to Zinathi International (Pty) Ltd.

We will only collect personal information that is necessary for the purposes described in this policy and will only process personal information in compliance with applicable laws, including the protection of Personal Information Act (POPIA) and in ways that are for, or compatible with, the business purposes for which the personal information was collected or that are subsequently authorised by you.

We may collect the following categories of personal information. Not all categories may be collected about every individual and this will depend on the purpose for which we need the personal information:

- a) Personal identifiers, such as name and address;
- b) Device and online identifiers and related information, such as telephone number and email address;
- c) Internet, application, and network activity, such as cookie IDs and browser visits;
- d) Government identifiers, such as CIPC registration numbers, national identification numbers and driver's license numbers;
- e) Demographic information, such as age and date of birth;
- f) Financial information, such as annual financial statements, bank statements, credit and debit card numbers and claims information;
- g) Purchase history information, such as products you have bought, rented, and returned;
- h) Location information, such as geo-location information;
- i) Audio, visual, and other sensory information, such as audio and video recordings;
- j) Employment information, such as occupation, title, licenses and professional memberships; or
- k) Individual preferences and characteristics, such as inferences related to shopping patterns and behaviours.

How do we collect information:

We collect information from you in a variety of ways. It may be:

- a) Provided directly by you;
- b) Collected from a device associated with you or your household;

Information provided by you

You actively share information with us in various ways in our store and online. For example, you share information when you:

- a) Make an in-store or online purchase, or other transaction, with us;
- b) Create an account on one of our websites or mobile services;
- c) Use a gift registry or create a mobile shopping list;

- d) Participate in our programs,
- e) Conduct a transaction or request a service where we collect information (including when required by law);
- f) Request customer service or contact us;
- g) Post a review or comment on one of our social media pages, or post a rating, review or other user generated content on one of our websites or mobile services; and
- h) Participate in a contest, promotion, or survey.

All personal information that is supplied to the Company must be accurate, up-to-date, not misleading and complete in all respects.

You undertake to immediately advise the Company of any changes to your personal information should any of these details change.

Our goal is to limit the information we collect to the information needed to support our business.

Information Collected From a Device Associated With You

You passively provide us information through technology. Some of this information may be linked to you personally. This information helps our websites and mobile services work correctly and supports our customer marketing and analytics efforts – our work to understand our customers’ needs and provide information about our products and services. Here are some examples:

- a) **Device Information:** We collect technical information when you visit our websites or use our mobile applications or services. This includes information such as Internet Protocol (IP) address, the type of mobile device you use, your device operating system and browser type, a unique device identifier, the address of referring websites, the path you take through our websites, and other information about your session on our websites.
- b) **Browsing Information:** We use our own and third-party technologies such as cookies, web beacons, and mobile device identifiers to collect information about the use of our websites and mobile services. We use these tools to provide an integrated and more personalized shopping experience for you. For example: cookies allow us to provide you relevant information as you use or return to our sites; web beacons allow us to know if a certain page was visited, an email was opened, or if ad banners on our websites and other sites were effective. Under certain circumstances, we permit third parties to collect information on our websites for their own business purposes using cookies, web beacons, iframes and similar technologies.
- c) **Precise Device Location Information:** We may collect information about your location when your device is set to provide location information.

Purpose for Collection of Personal Information

The information collected and processed by Zinathi may be used for the following purposes:

- a) To fulfill your order or requests for services and provide customer service;
- b) To create and maintain your account;
- c) To conduct auditing and monitoring of transactions and engagement;
- d) To conduct marketing, personalization, and third-party advertising, subject always to your right at any time to opt out of such communication.
- e) If you want to remove your contact information from all lists and newsletters, please unsubscribe at the bottom of any of the marketing email or forward an unsubscribe request to info@zinathi.com from the address you wish to unsubscribe.

- f) To protect the security and integrity of our websites, mobile services and our business, and help prevent fraud;
- g) To update our operational and technical functionality;
- h) To conduct business analysis, such as analytics, projections and identifying areas for operational improvement;
- i) To conduct research and development; or
- j) To fulfil our legal functions or obligations.

All Personal Information which you provide to the Company will be used and/or retained only for the purposes for which it is collected, whereafter it will be permanently destroyed. We will only retain personal information for longer than the purpose for which it was collected if it is required by law or where you have given consent for us to retain such information for an extended period.

Sharing of Personal Information

Legal Requirements and Protection of Our Company and Others-

We may share your personal information in other special circumstances, which include situations when sharing is required by law, or we believe sharing will help to protect the safety, property, or rights of Zinathi, our customers, our associates, or other persons. Examples include:

- a) Protecting the health or safety of customers;
- b) Addressing crimes committed on Zinathi property;
- c) Identifying and addressing fraud or financial risk;
- d) Providing personal information from cameras to law enforcement at their written request;
- e) Responding to a search warrant or other valid legal inquiry; and
- f) Responding to an investigative body in the case of a breach of an agreement or violation of law.
- g) Arrangement of deliveries of purchased items

Courier Services

Zinathi makes use of the Courier Guy's services for the delivery of the online purchases.

We will share your delivery address, name, contact number and email address to enable a delivery.

By using our websites, mobile applications, Wi-Fi and/ or by providing your information to us, you agree to the practices described in this policy and you agree to Zinathi International (Pty) Ltd, its directors, officers, employees, servants, agents and/or contractors and/or other third parties to process (which will include collecting, using and disclosing) your personal information for the purposes stated in this policy.

If you do not agree to this policy, please do not use our websites, mobile applications, Wi-Fi and/ or provide your information to us. Any use by you of our websites, mobile applications, Wi-Fi and/ or any provision by you of your information will be deemed to constitute your acceptance of the terms in this policy.

Security

The security and confidentiality of your personal information is important to us.

We have implemented technical, administrative, and physical security measures to protect your personal information from unauthorised access or disclosure and improper use. Access to your personal information is restricted to only to those employees who need the personal information to perform a specific job / task.

All employees with access to Personal Information are kept up-to-date on our security and privacy practices.

We are committed to ensuring that our security measures which protect your personal information are continuously reviewed and updated where necessary. It is important for you to protect yourself against unauthorised access to your account password. Whilst we will do all things reasonably necessary to protect your personal information, we cannot guarantee nor do we accept any liability of whatsoever nature for any unauthorised or unlawful disclosure and/or use of your personal information, either by employees and/or made by any third parties (including third party service providers) who are not subject to our control, unless such disclosure and/or use is as a result of our gross negligence.

Your rights

Upon reasonable request and in accordance with POPIA, we will grant customers reasonable access to their personal information and will permit them to correct, amend or delete personal information that is incomplete or inaccurate.

Should you so request, we will provide you with the record or a description of the personal information which we have about you, including information about the identity of all third parties who have, or have had, access to the personal information:

- a) within a reasonable time;
- b) at a prescribed fee, if any;
- c) in a reasonable manner and format; and
- d) in a form that is generally understandable.
